ARTICLES OF INCORPORATION

OF

JAX'S PILOT ESCORT INC.

ARTICLE I - NAME

The name of this corporation is JAX'S PILOT ESCORT INC.

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing on the date of signing.

ARTICLE III - PURPOSE
