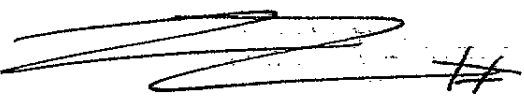

ARTICLES OF INCORPORATION

OF

In compliance with the requirements of FS. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The initial board of directors shall consist of three (3) members, The names and address of the persons who will service on the initial board of directors are:

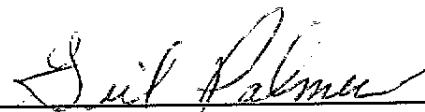
