The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

**ARTICLE ONE - NAME**

The name of the corporation shall be: **KARPA DEUM, INC.**

**ARTICLE TWO - PRINCIPAL OFFICE**


3. All other management and regulations shall be at the discretion of the Board of Directors.
