
ARTICLE XI



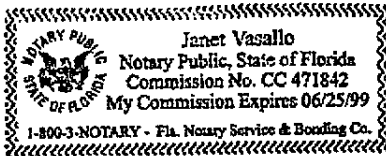
