ARTICLES OF INCORPORATION

of

I, the undersigned incorporator of this corporation, under Florida Statute 607, as amended, adopt the following Articles of Incorporation.

ARTICLE I. NAME

ARTICLE IX. PREEMPTIVE RIGHTS

Value of the stock shall be determined by a disinterested appraiser.

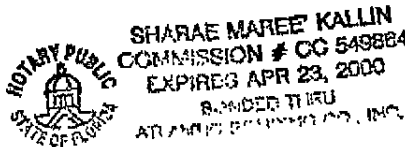


