ARTICLES OF INCORPORATION

OF

COIN TREK, INC.

ARTICLE I. NAME. The name of the corporation shall be COIN TREK, INC.

ARTICLE II. DURATION. The corporation shall exist perpetually.

ARTICLE III. PURPOSE. The purpose of this corporation is for a coin laundry and for the transaction of any lawful business for which corporations may be incorporated under the law of the State of Florida.






