THE UNDERSIGNED, acting as sole incorporator of **PARAGON CLEANING SYSTEMS, INC.** under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I
NAME**

INITIAL BOARD OF DIRECTORS

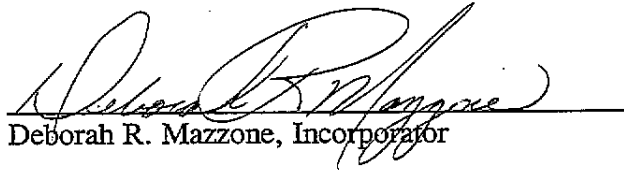

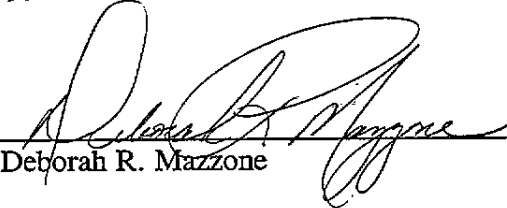
