

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:


Article I. Name. The name of the corporation shall be CAPITOL MALL, INC.

Article III. Shares. The number of shares of stock that this corporation is authorized to have outstanding at any one time is 5,000 common shares.


