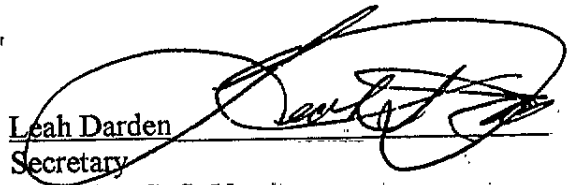

ARTICLES OF INCORPORATION

TRANS/CONTINENTAL HOME IMPROVEMENT & URBAN DEVELOPMENT INC.

We, the undersigned, hereby associate together for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the Statutes of Florida.

ARTICLE I

The name of the corporation shall be:

ARTICLE II

The general nature of business and the objects and purposes proposed to be transacted and carried on, are to do any and all activities or business permitted under the laws of the United States and of this State, as fully and to the same extent as natural persons might or could do.

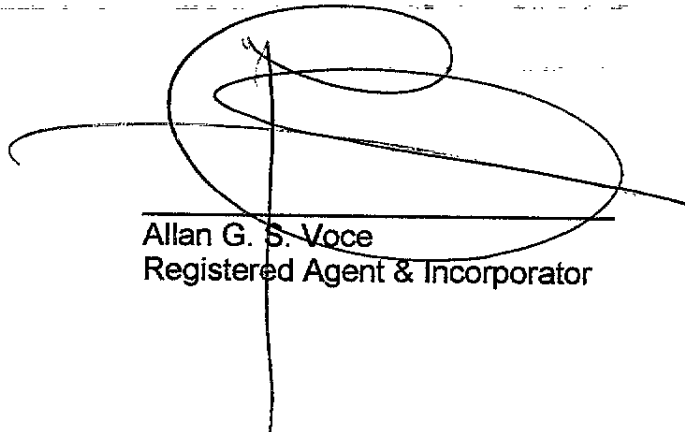
