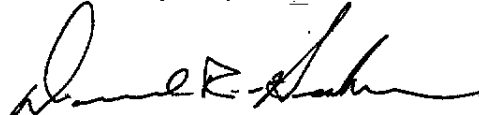

ARTICLES OF INCORPORATION

The undersigned subscribers to these Articles of Incorporation are natural persons competent to contract for a corporation under the laws of the State of Florida, and does certify that they have become a corporation pursuant to the following Articles of Incorporation.

ARTICLE ONE

The name of this corporation is AAA Pawn, Incorporated.

ARTICLE TWO

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory, or nation.

ARTICLE THREE

The corporation shall have all the powers given to it by the laws of the State of Florida, now or hereafter, and specific powers herein enumerated shall not be construed as a limitation upon the powers of the corporation.

ARTICLE FOUR

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is Ten Thousand (10,000) shares of common stock with a nominal par value of One (\$1.00) Dollar.

ARTICLE FIVE

The amount of capital with which this corporation will begin business is a minimum of Five Hundred (\$500.00) Dollars.

ARTICLE SIX

This corporation is to exist perpetually.

ARTICLE SEVEN

The initial post office address of the principal office of this corporation is in the State of Florida, County of Brevard, at P.O. Box 364, Mims, Fl, 32754. The Board of Directors may from time to time move the principal office to any other address in the State of Florida.

ARTICLE EIGHT

This corporation shall have one director initially. The number of directors may be increased or diminished from time to time by bylaws adopted by the stockholders, but shall never be less than one.

ARTICLE NINE

The name of the members of the first Board of Directors who are to serve as directors until the first annual meeting of shareholders or until their successor or successors are elected and shall qualify are:

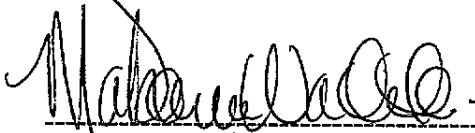
