**ARTICLE I**

The name of this corporation is: Sea Snake.com, Inc. The principal office of the corporation is located at 413 First Street South, #301, Jacksonville Beach, Florida 32250.

**ARTICLE II**

This corporation is organized for the purpose of transacting any or all lawful business permitted under the Laws of the United States and of the State of Florida.

**ARTICLE III**

The total number of authorized shares of the capital stock of this corporation is One Thousand (1,000) shares, of a single class of voting common stock, all of which shall have a par value of Ten Cents (\$.10) each. Each issued and outstanding share of common stock shall be entitled to one vote.


