ARTICLES OF INCORPORATION OF

ARTICLE I - NAME

The name of this corporation is: M & M 99 CENTS STORE, INC., with the principal place of business located at: 8187NW 8TH STREET STE 107, MIAMI, FL. 33126.

ARTICLE II - PURPOSE
