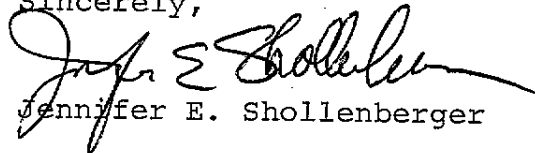

ARTICLES OF INCORPORATION
OF
JENNIFER E. SHOLLENBERGER, PA

Article I - Name

The name of this corporation is:
Jennifer E. Shollenberger, PA

Article II - Business and Activities

This corporation may, and is organized and authorized to, engage in any activity or business permitted under the laws of the United States and the State of Florida. Accordingly, this corporation/professional association will sell certified rehabilitation services for profit through its registered nursing staff to the public.

Article III - Capital Stock

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 1,000 shares of common stock having a par value of \$1.00 per share, with the consideration to be paid for each share to be in money, property or services, as may be fixed by the Board of Directors.

Article IV - Term of Existence

This corporation shall have a perpetual existence.

Article V - Initial Registered Office and Agent

The street address of the initial principal and registered office of this corporation is 2087 Haas Road, Apopka, Florida, 32712. The name of the initial registered agent of this corporation at that address is Jennifer E. Shollenberger.

Article VI - Initial Board of Directors

This corporation shall have one (1) director initially. The number of directors may be either increased or diminished from time to time by the by-laws, but shall never be less than one.

The directors of this corporation may take action by written consent, as provided by law.

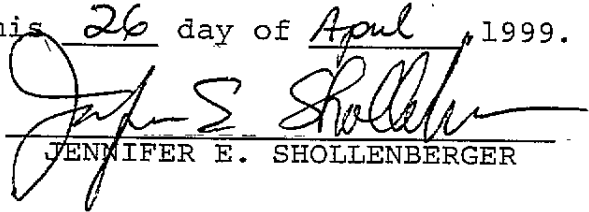
Article XI - Indemnification

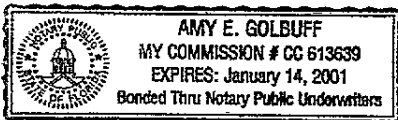

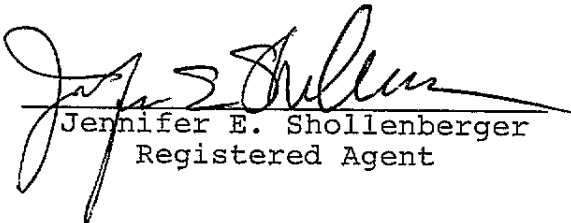
