### ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation undersigned.

Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

### ARTICLE I

The shareholders shall have the power to adopt, amend, alter, change, or repeal the Articles of Incorporation when proposed and approved at a stockholder's meeting, with no less than a two-thirds vote of the common stock.

# ARTICLE IX

The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors.

### ARTICLE X
