

# TAMA CORPORATION

The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida.

#### ARTICLE I

## NAME OF THE CORPORATION

The name of the corporation shall be:

## ARTICLE II

# **DURATION OF THE CORPORATION**
