OF INCORPORATION:

**ARTICLE I - NAME**

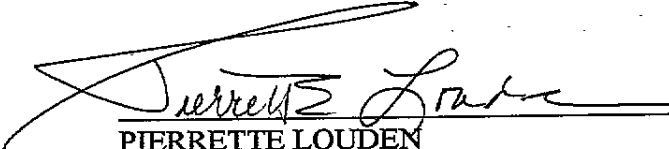

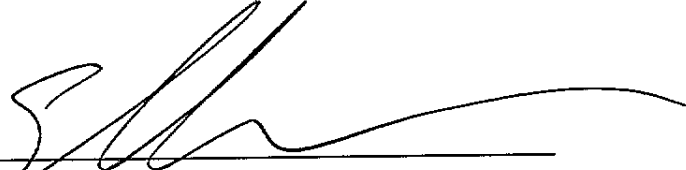
