

ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME - LOCATION

The name of this corporation is M. E. P. INSPECTIONS, INC. at 10257 Breezeway Place,
Boca Raton, Florida 33428.

ARTICLE II - DURATION

This corporation shall exist perpetually.


ARTICLE IX - AMENDMENT




