

**ARTICLES OF INCORPORATION
OF
CAROL A. SILVERMAN, RN., CONSULTANT TO ATTORNEYS, INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I
