# ARTICLES OF INCORPORATION FOR RN CONSULTING, INC.



The undersigned subscribers, hereby associate themselves together to form a corporation for profit under the laws of the STATE OF FLORIDA: and hereby adopt the following ARTICLES OF INCORPORATION.

### ARTICLE I NAME
