

ARTICLE I - NAME - LOCATION

The name of this corporation is SHANKH, INC, located at 1844 North Nob Hill Road, Suite 445, Plantation, Florida 33322.

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing on the date of execution and acknowledgment of these articles.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.



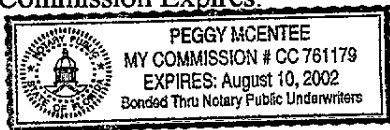


