Article I <u>- Name</u>

The name of this corporation is Floridian Realty Ventures, Inc. and its principal office is located at 4400 Pinewood Road, Melbourne, Florida 32934.

Article II - Duration

This corporation shall exist perpetually. The date of commencement of corporate existence shall be the date these articles are filed with the Secretary of State.

Article III - Purpose
