# ARTICLES OF INCORPORATION OF FLORIDA HYGIENE SERVICES INC.

99 PR 29 PH 1:27

The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida.

#### ARTICLE I - Name

The name of the corporation is Florida Hygiene Services Inc.

#### ARTICLE II - Commencement of Existence and Duration

This corporation is to commence its corporate existence on the date of the filing of these Articles of Incorporation pursuant to Fla. Stat. §607.167 and shall exist perpetually thereafter until dissolved sooner according to law.

## ARTICLE III - Purpose

The corporation is organized for the purpose of transacting any and all lawful business.

# **ARTICLE IV - Stated Capital**

The corporation is authorized to issue 100 shares of ONE DOLLAR (\$1.00) par value common stock. Each outstanding share, regardless of class, shall be entitled to one vote on each matter submitted to a vote at a meeting of the shareholders.

The shares of stock may be issued for such consideration, having a value not less than the par value of the shares issued therefor, as is determined from time to time by the Board of Directors, to be paid, in whole or in part, in cash or other property, tangible or intangible, or in labor or services actually performed for the corporation. Shares may not be issued until the full amount of the consideration therefor has been paid. Thereafter, such shares shall be deemed to be fully paid and non-assessable.
