The number of shares of stock is: ONE THOUSAND (1,000) shares at a \$0.01 par value per share.

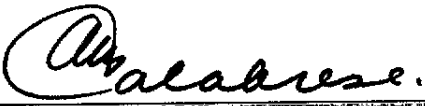

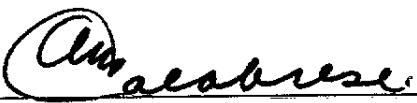
