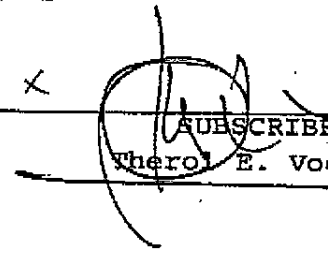
Article IX - Bylaws

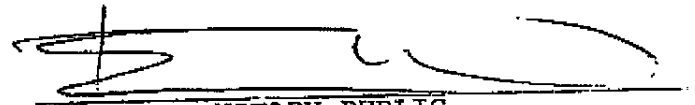
