## ARTICLES OF INCORPORATION

OF

# BUSY BEE RECYCLING, CORP.

WE, the undersigned, hereby associate ourselves together for the purpose of organizing a corporation under the Laws of the State of Florida, providing for the formation for profit, with the powers, rights, privileges and immunities hereinafter mentioned, and we make, subscribe and acknowledge, and file with the Secretary of State for the State of Florida, this Certificate of Incorporation, and to that end we do, by these Articles, set forth:

## ARTICLE I

The name of this corporation shall be:

The general nature of the business to be transacted by this corporation shall be:

## Term of Existence

The term of existence of this corporation shall be perpetual.

## ARTICLE VI

The principal office and place of business of this corporation shall be 1850 Hibiscus Drive, North Miami, Florida 33181, with the privilege of establishing other offices and places of business throughout the State of Florida and in any of the several states, territories, possessions and dependencies of the United States of America, the District of Columbia and in foreign countries, as may be designated by vote of the stockholders.
