The undersigned incorporator DAVID L. DOUGHTERY, JR. hereby forms BIG DADBYS CRAB HOUSE AND OYSTER BAR, INC., a Florida General Corporation Act and other laws of the State of Florida.

1. <u>NAME OF CORPORATION AND INITIAL ADDRESS</u>: The name of this corporation shall be BIG DADDY'S CRAB HOUSE AND OYSTER BAR, INC. and its address is 8100 Thomas Drive, Panama City Beach, Florida 32408.
