

## ARTICLE 1. - NAME

The name of this corporation is JUNGE'S MACHINING, INC.

## ARTICLE 2. - DURATION

This corporation shall exist perpetually unless dissolved according to Florida law.

#### ARTICLE 3. - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.
