Pursuant to Section 607.1006 of the Florida Business Corporation Act, the indersigned corporation adopts the following Amendment to its Articles of Incorporation:

- 1. The name of the corporation is First Global Solutions Inc.
- 2. The following amendments to the Articles of Incorporation have been adopted as follows:

Article III is hereby deleted and the following inserted in place thereof:

#### ARTICLE III

The Corporation shall have authority to issue 5,000,000 shares of stock, all of one class, with a par value of \$.10 per share.
