ARTICLES OF INCORPORATION
OF

The undersigned, acting as the Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

This corporation shall have perpetual existence unless dissolved according to law.

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 100 shares of common stock. Said shares of common stock having a par value of one dollar (\$1.00) each.
