ARTICLE I - NAME OF CORPORATION

The name of the corporation shall be Reflections Janitorial Corp.




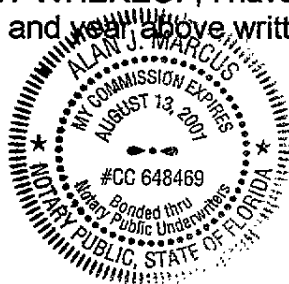
