ARTICLE I.

NAME

The name of the Corporation is: J & B CARPENTRY, INC.

ARTICLE II.

DURATION

This Corporation shall have perpetual existence.

ARTICLE III.

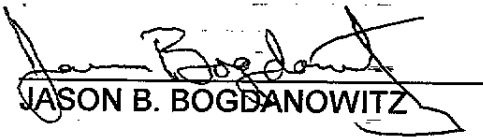
