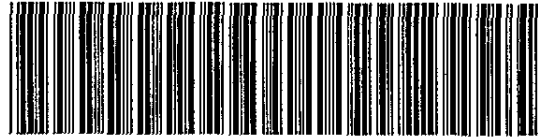

THIRD: The file date of the Article of Incorporation of the Corporation is: May 6, 1999.

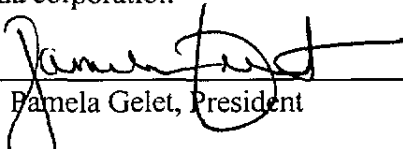
THIRD: The date dissolution was authorized: 30th day of December, 2003.
