**To Whom it May Concern:**


I am enclosing a check for \$300.00 for 2000 & 2001 annual fees for Country Club Real Estate, Inc.. As per my conversation with your department on November 19, 2001 I am writing this letter to explain why this occurred and to ask that you do not charge me the cost of reinstating my company.

My father Stefan Stampler died in February 2000 of ALS (Lou Gehrig's Disease) which he had been fighting for his life for almost 3 years. We really thought we were going to lose him in December of 1999 when he took a real turn for the worse. Somehow he managed to make it month to month thru February of this year. I have enclosed his death certificate as well. During the last couple years of his life I had to assist in running his mortgage company for him to help support my parents who incurred a severe loss of income coupled with extremely high medical expenses.

I feel embarrassed to have to explain this set of circumstances, but there is also more to this story. During this time period my marriage of 9 years with two small children began to suffer as well. The emotional strain I was under was overwhelming between losing my father who I was extremely close to and watching my marriage fall apart at the same time. I ended up finally getting divorced in May of this year also. I have enclosed my dissolution of marriage as well.

Needless to say this has been the most difficult 2 years of my life and I am attempting to put my life back together. I have spent this past year and a half in therapy trying to get a grip and move on with my life again. I truly hope that your department could see fit to accept my \$300.00 and waive the reinstatement charge under this unusual set of circumstances.
