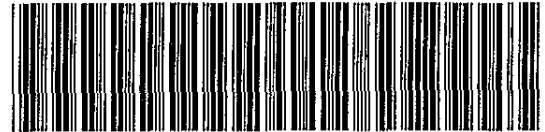

**THIRD:** The file date of the Article of Incorporation of the Corporation is: May 6, 1999.

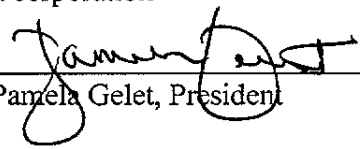
**THIRD:** The date dissolution was authorized: 30<sup>th</sup> day of December, 2003.
