The street address of the initial registered office, the principal office and mailing address of the corporation is 10277 SW 64th Court, Ocala, Florida 34476.

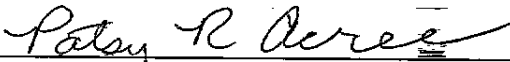
**ARTICLE VI - Initial Registered Agent-

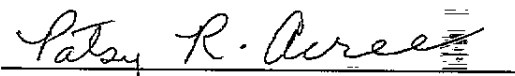
