WE THE UNDERSIGNED, hereby associate ourselves together for the purpose of becoming a coporation under Laws of the State of Florida, by and under the provisions of the Statutes of the said State of Florida.

ARTICLE 1

The name of this coporation shall be:

Morris Construction Enterprize Inc.

ARTICLE 2

The coporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE 3

The maximum number of shares of capital stock that this coporation is authorized to have outstanding at any one time is **Five Hundred (500.00)** shares of common stock, having a par vale of ONE (1.00) DOLLAR PER SHARE.

ARTICLE 4

ARTICLE 10

To enter into, make and perform contracts of every kind for any lawful purpose, with any person, firm, association, corporation, municipality, state, or government, or any political or other subdivision of any of the same.

ARTICLE 11

To purchase or otherwise acquire, sell, assign, and transfer, exchange or otherwise dispose of, and to invest, trade, deal in or deal with goods, wares and merchandise and personal property of every class description.

## ARTICLE 12

To apply for, obtain, purchase, take licenses in respect of or otherwise acquire, and to hold, own, use, grant, pledge or otherwise dispose of, and in any manner deal with, any and all inventions, devices, processes and any improvement and modifications thereof; and any and all letters patent of the United States or of any other country, state, territory, or locality, and all rights connected therewith or appertaining thereunto; any and all copyrights granted by the United States or any other country, state, territory, or locality; and any and all trade-marks, trade names, trade symbols and other indications of origin and ownership granted by or recognized under the laws of the United States or of any other country, state, territory, or locality.

## ARTICLE 13
