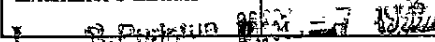

The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

**Article I
Name**

The name of the corporation shall be:

**Article II
Purpose**

The general purpose for which the corporation are the following:

- A. To engage in the business to purchase, organize, plan and conduct sales (Import and Export) and services to European Nations, the Caribbean and through out the United States.

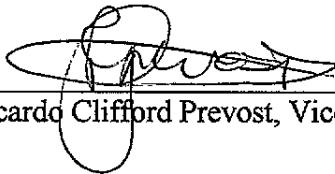
