ARTICLE OF INCORPORATION

OF

CHILDREN OF LIGHT PUBLISHING, INC.

ARTICLE I - NAME

The name of the corporation is: CHILDREN OF LIGHT PUBLISHING, INC.

ARTICLE II - DURATION

This corporation shall exist perpetually.

ARTICLE III - PURPOSE

This corporation is created and shall exist for the purpose of assisting its shareholders and incorporators in engaging in the business of creating and publishing songs, poems and similar works of art within the State of Florida.
