## ARTICLES OF INCORPORATION OF M.J.P. Flooring, Inc.

ARTICLE I - NAME

The name of this corporation is M.J.P. Flooring, Inc. (hereinafter referred to as the "Corporation").

#### ARTICLE II - DURATION

The Corporation shall exist perpetually, commencing on the date of May 1, 1999 filing these Articles with the Department of State.

#### ARTICLE III - PURPOSE

The Corporation is organized for the purpose of transacting any or all lawful business not inconsistent with the laws of the State of Florida.


ARTICLE IV - CAPITAL STOCK

Every shareholder, upon the sale for cash of any new stock of the Corporation of the same kind, class, or series as that which he or she already holds, shall have the right to purchase his or her pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI - TRANSFERABILITY OF SHARES
The transferability of all shares of stock in the Corporation shall be restricteAd in accordance with this Article VI. No shareholder nor any shareholder's heirs, executors or administrators shall sell, exchange, give, transfer, pledge, hypothecate or otherwise dispose of any shares in the Corporation or any interest in the shares except with the express written consent of other shareholders of the Corporation holding, in the aggregate, not less than one-half of all the outstanding shares of stock in the Corporation.

ARTICLE XIII - AMENDMENT

This corporation reserves the right to amend or repeal any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.
