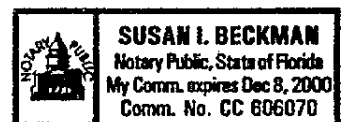

ARTICLE I - NAME AND LOCATION

The undersigned, acting as incorporator under the Florida Business Corporation Act, adopts the following Articles of Incorporation for Employment Express Inc.

This corporation shall be perpetual commencing and effective immediately upon filing these Articles of Incorporation.

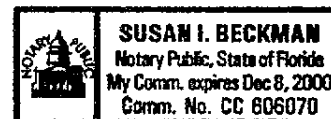
ARTICLE III - PURPOSE

ARTICLE VI - INITIAL BOARD OF DIRECTORS

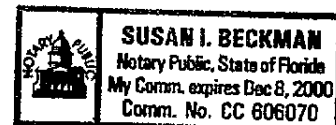

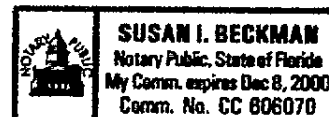
