ARTICLES OF INCORPORATION

OF

W. IVERY MASONARY INC.

Article I - Name

The name of the corporation is: W. IVERY MASONARY INC.

Article II - Duration

This corporation shall exist perpetually.

Article III - Purpose

Article IV - Capital Stock
