

ARTICLES OF INCORPORATION
OF

APEX ENTERPRISES OF MIAMI, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE I

NAME AND ADDRESS:

The name of this corporation shall be:
APEX ENTERPRISES OF MIAMI, INC.

ARTICLE II

PURPOSE

The purpose for which the corporation is organized is to transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

DURATION

The term of existence of the corporation is perpetual.

ARTICLE IV

CAPITAL STOCK

The Aggregate number of shares which the corporation has authority to issue is 100, all of which shall be common shares with no par value.


The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.
