ARTICLES OF INCORPORATION

OF

BY THESE ARTICLES OF INCORPORATION, the incorporator forms a corporation for profit under Florida law.

ARTICLE I

1. $\underline{\text{NAME}}$. The name of the corporation is GRATEFUL FITNESS, INC.
