**Article I - Name**

The name of the corporation is: McClurg Enterprises, Inc.


#### **Article IX - Initial Officers**



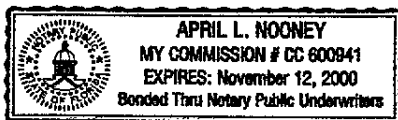


