ARTICLES OF INCORPORATION
OF
SURE SET, INC.

We, the undersigned, for the purpose of incorporation under the laws of the State of Florida, provide for the formation, liabilities, rights, privileges and immunities of a corporation for profit.

ARTICLE I

NAME

The name of this corporation shall be: SURE SET, INC.

ARTICLE II

GENERAL NATURE OF BUSINESS

The general nature of business and the objects and purposes proposed to be transacted by this corporation is any activity or business permitted under the laws of the State of Florida, and the laws of the United States of America and for the installation of manufactured/mobile homes.

ARTICLE III

CAPITAL STOCK

The amount of capital stock for this corporation shall be One Hundred (100) shares having a par value of One Hundred Dollars (\$100.00) per share.

ARTICLE IV

AMOUNT OF CAPITAL WITH WHICH TO BEGIN BUSINESS

The amount of capital with which this corporation shall commence is not less than One Thousand Dollars (\$1,000.00).

ARTICLE V

CORPORATE EXISTENCE

This corporation shall have perpetual existence unless sooner dissolved according to law.

ARTICLE VI

PRINCIPAL PLACE OF BUSINESS

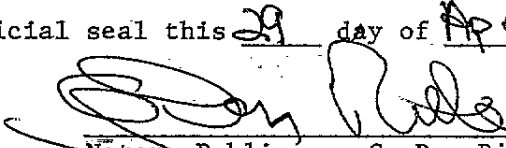

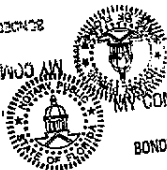

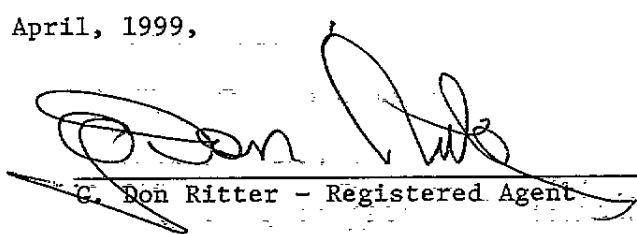
