ARTICLES OF INCORPORATION OF DEBORAH K. HAUSMAN, P.A.



The undersigned subscriber, Deborah K. Hausman, a natural person competent to contract, for the purpose of forming a corporation under the laws of the State of Florida, adopts the following Articles of Incorporation.

ARTICLE I - NAME
