#### ARTICLES OF INCORPORATION

OF

#### POOLSKIM, INC.

The undersigned subscriber to these Articles of Incorporation, being a natural person competent to contract, hereby makes, subscribes and acknowledges these Articles of Incorporation in accordance with the laws of the State of Florida.

### ARTICLE I

The name of this corporation is POOLSKIM, INC.

### ARTICLE II

The nature of the business and the objects and purposes proposed to be transacted by the corporation are:

- 1. To acquire for wholesale and retail sales and distribution, "poolskim" appliances including succeeding models and further improvements thereto.
- 2. To engage in the business of selling commercial and residential pool cleaning devices, equipment and machinery.
- 3. To manufacture, produce, purchase or otherwise acquire, own, deal in, sell, pledge, or otherwise dispose of, at wholesale and retail, equipment, accessories and chemical supplies used in the manufacturing, production and maintenance of private and commercial swimming pools; all water sports equipment and paraphernalia used in water sports; chemicals of every description, acids, alkalies and salts, paints, oils, varnishes, colors and pigments, drugs and pharmaceutical preparation, which can be used

in the testing or purification of water used in swimming pools; and all articles or materials necessary or useful in connection therewith; and in general, goods, wares and merchandise of every description.

4. This corporation shall have all the powers, general or specific, specified, granted to or conferred upon corporations for profit under the provisions of Chapter 607, Florida Statutes, and all of the laws which are amendatory and supplementary to such law. The enumeration of specific powers herein shall in no way limit or restrict this corporation in the exercise of such powers.

## ARTICLE III

The maximum number of shares of stock that the corporation is authorized to have outstanding at one time is 10,000 shares of common stock, having a par value of \$1.00 per share.

#### ARTICLE IV

If the holder of stock in this corporation should desire to sell the same or any part thereof, and has a bona fide offer to purchase said stock from an outsider, he must first offer said stock to the corporation on the same price, terms and conditions, and the corporation shall have thirty (30) days to purchase said stock. If the corporation shall thereafter fail to exercise this option, the holder shall be free to sell to the offeror.

#### ARTICLE V

This corporation is to exist perpetually.
