ARTICLES OF CORRECTION

OF

BYE BYE NOW.COM, INC.

Article I. Name

The name of this corporation is BYE BYE NOW.COM, INC. (the "Corporation").

Article II. Correction

The Second Amended and Restated Articles of Incorporation of the Corporation, filed on May 10, 2000, are corrected as follows:

Article I, which states the street address of the principal office of the Corporation, is incorrect. Article I should read as follows:

The name of the Corporation shall be Bye Bye Now.Com, Inc. The street address of the principal office of the Corporation shall be I 100 Park Central Boulevard South, Suite 1800, Pompano Beach, FL 33064.

All references in Article II Section 4(a) to Section 5(b) are incorrect. Article II Section 4(a) should read as follows:

(a) General. Subject to, and in compliance with, the provisions of this Section 4, any share of the Series A Preferred Stock, Series B Preferred Stock, Series C Preferred Stock, Series D Preferred Stock and Series E Preferred Stock may, at the option of the holder, be converted at any time into fully-paid and non-assessable shares of Common Stock. The number of shares of Common Stock to which a holder of Series A Preferred Stock, Series B Preferred Stock and Series C Preferred Stock shall be entitled shall be the product obtained by multiplying the Applicable Conversion Rate (determined as provided in Section 4(b)) by the number of shares of Series A Preferred Stock, Series B Preferred Stock and Series C Preferred Stock being converted. The number of shares of Common Stock to which a holder of Series D Preferred Stock shall be entitled upon conversion shall be the product obtained by multiplying the Series D Series D Preferred Stock being converted. The number of shares of Common Stock to which a holder of Series E Preferred Stock shall be entitled upon conversion 4(b)) by the number of shares of Series E Preferred Stock shall be entitled upon conversion shall be the product obtained by multiplying the Series E Applicable Conversion Rate (determined as provided in Section 4(b)) by the number of shares of Series E Preferred Stock shall be entitled upon conversion shall be the product obtained by multiplying the Series E Applicable Conversion Rate (determined as provided in Section 4(b))

Article IV, which states the street address of the registered office of the Corporation, is incorrect.

Article IV should read as follows:
