- The name of the corporation is: Big Bend Association of Research Professionals, INC. Chapter of ACRP
- The period of duration of the corporation is: perpetual.
- The address of its initial Registered Office in the State of Florida is: 2000 Centre Pointe Blvd, TLH FL 32308 and the name of its Registered Agent at said Address is: Kellie J. Krasinski, RN
- The first directors shall be 2 in number, their names and address being as follows:

- The purposes for which the corporation is organized are:
 - To provide and advanced level of continuing education programs in the area of clinical research
 - To support, promote, and advance the goals and objectives of the Associates of Clinical Pharmacology as outlined in its constitution and bylaws.
- This corporation is organized exclusively as an educational league, not organized for profit, under Section 501 (c) (3) of the Internal Revenue Code of 1954, as amended.

7. No part of the net earnings of the corporation shall inure to the benefit of, or be distributed to, its members, trustees, officers, directors or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein.
8. There shall be no stock issued by the corporation.
9. Upon dissolution of the corporation, the directors shall, after paying or making provisions for the payment of all liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purpose of the corporation in such manner, or to such organization or organizations, organized and operated exclusively as business leagues, as shall at the time qualify as exempt organizations under Section 501 (c) (3) of the Internal Revenue Code of 1954, as amended, as the directors shall determine.
10. Except as otherwise specifically provided by statute, all powers of management and direct control of the corporation shall be vested in the officers.
11. No contracts or other transactions between this corporation and any other firm or corporation shall be affected or invalidated by reason of the fact that any of the members, trustees, directors, or officers of the corporation are interested in, or are members, shareholders, directors or officers of such firms or corporations; and any member, trustee, director, or officer of this corporation may be a party to or may be interested in any contract or transaction of this corporation or in which this corporation is interested and no such contract shall be affected or invalidated thereby; and each and every person who may become a member, trustee, director, or officer of this corporation is hereby relieved from any liability that might otherwise exist from his or her contract with this corporation for the benefit of himself or herself or for any other person, firm, association or corporation in which he or she may be in any way interested.
12. The corporation shall have the following powers, in addition to those provided by law:
 - a. To buy, sell, deal in, handle, hold, own, lease, devise, transfer, and receive title to real and personal property in its own name, by devise, bequest, gift, grant, purchase, or other conveyance, as may be necessary for the conduct of the business of the corporation; and
 - b. To produce and present to the public exhibitions, movies, radio programs, and other information, verbal and written to promote the purposes of the corporation.
