ARTICLES OF INCORPORATION

OF

SCOTT WOLFSON DESIGN, INC.

ARTICLE I - NAME

The name of this Corporation is:

Scott Wolfson Design, Inc.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this Corporation is:

ARTICLE III - DURATION
